

**GREENWOOD COUNTY COMMISSION MEETING**  
**AUGUST 22, 2022**

Chairman Roy Ballard called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Ben Fox, Robert Morgan, Chuck Spradlin, Paul Hodge, County Counselor Paul Dean and County Clerk Kathy Robison.

Commissioners led everyone present in the Pledge of Allegiance.

*Fox moved to approve August 15, 2022 Minutes, as written. Morgan seconded. Motion carried 5-0.*

Road and Bridge Report:

- There is currently one county dump truck in the shop for repair.
- The lowboy is being rebuilt.
- The bobcat has a leak.
- Darrel has not heard anything regarding the Reece Road project.
- Ballard noted there is a wooden bridge approach in need of repair.
- Phone lines at Road and Bridge have been repaired.

Commissioners reviewed Treasurer's report and monthly fee reports for June 2022. No decisions were made.

*Morgan moved to approve payables in the amount of \$231,869.81. Fox seconded. Motion carried 5-0.*

*Morgan moved to approve payroll in the amount of \$123,338.17. Hodge seconded. Motion carried 5-0.*

Greenwood County resident Joe Spencer attended the meeting to discuss roads near Vaughn Acres. Spencer asked commissioners how close a building or fence can be to easements and right of ways. It was noted that a building/fence can be erected up to the right of way/easement provided they do are not in the right of way/easement.

Paul Hodge noted that the low water crossing on State Street is still an issue.

Fox noted that Lucas Mullin volunteered for the vacancy on the Greenwood County Hospital Board.

*Fox moved to appoint Lucas Mullen to the Greenwood County Hospital Board vacancy. Spradlin seconded. Motion carried 5-0.*

Ballard read a letter received from a Greenwood County resident regarding the status of GG Road. Said resident would like the county to continue to maintain GG Road rather than consider it as a low maintenance road. Following a brief discussion regarding the matter, commissioners noted that they have not deemed GG Road as minimum maintenance and Salt Springs Township does not have the authority to do so; therefore, the township will continue to maintain GG Road as they have in the past.

County Clerk Kathy Robison noted that there are a few CDBG loans that are not collectable.

*Spradlin moved to approve an amount of \$19,981.95 as a write-off for CDBG loans that cannot be collected. Ballard seconded. Motion carried 5-0.*


*The following write-offs were approved:*

- *Brian's Equipment in the amount of \$280.06*
- *Carrie Odell in the amount of \$10,751.89*


*Fox moved to adjourn at 9:54 a.m. Spradlin seconded. Motion carried 5-0.*




