

GREENWOOD COUNTY COMMISSION MEETING  
MAY 9<sup>TH</sup>, 2022

Chairman Roy Ballard called the regular meeting of the Greenwood County Commissioners to order at 9:00 a.m. Other members present were Ben Fox, Paul Hodge, Robert Morgan, County Counselor Paul Dean and County Clerk Kathy Robison. Commissioner Chuck Spradlin was not in attendance.

Commissioners led everyone present in the Pledge of Allegiance.

Road and Bridge Report:

- Christian Hills Bridge is slated to be closed by noon on Wednesday, March 11.
- Chrisman placed a bid on a truck in the amount of \$80,200.
- Crews are cleaning debris off roadways and repairing washouts.
- Ballard informed Darrel that repairs are needed on a culvert, north of Bitler Bridge due to safety matters: he suggested that county crews make the necessary repairs and bill the townships.

*Hodge moved to approve May 3<sup>rd</sup>, 2022 Minutes, as written. Morgan seconded. Motion carried 4-0.*

*Hodge moved to approve zoning for Salt Creek Post & Frame LLC. Morgan seconded. Motion carried 4-0.*

*Fox moved to approve special payables in the amount of \$13,091.81. Morgan seconded. Motion carried 4-0.*

Emergency Management Supervisor Levi Vinson presented Hazard Mitigation paperwork for commissioners to sign. This will allow Greenwood County to receive hazard mitigation funds from FEMA, if necessary. Vinson then informed commissioners that he needed to take his county vehicle to the dealer. Commissioner Ballard stated that he could fix the issue for around \$15.

A brief discussion regarding the contract with Oklahoma LED was held. Ballard informed fellow commissioners that his understanding was that Oklahoma LED will replace lights and fixtures; the fixtures were not replaced in the offices. County Clerk Kathy Robison will review Minutes from that meeting and get them to the commission; legal Counsel Paul Dean will also review the contract.

*Fox moved to approve a 20-minute executive session for personnel with County Fire Chief Doug Williams. Hodge seconded. Motion carried 4-0. Meeting reconvened at 9:57 a.m. No decisions were made.*

Doug Williams will resign as Greenwood County Fire Chief as of June 30<sup>th</sup>, 2022. Williams has offered to help the county during the transition period.

*Fox moved to adjourn at 10:05 a.m. Morgan seconded. Motion carried 4-0.*
